

POST-RELEASE CONTROL CONSULTANCY


Post-release control can be made controllably in places for the customs clearance of the goods including the accuracy of the information declared and whether the transactions are duly made and/or trade documents and data regarding following trade processes or where the risky person or transactions belong to the relevant persons. The Post-Release Control and Risky Processes Guide was published the Official Gazette dated 27.10.2008 and with no. 27037 subject to provisions of Article 10 and 73 of Customs Law with no. 4458, and its de facto application took place in 2009 (as covering the last 3 years retrospectively from the starting date).

We, Özsoy Gümrük A.Ş, support you for your transactions which may be found risky by the audit staff and during audit especially in the content of post-release control before the audit. With this audit and consultancy services we aim to prevent possible financial, administrative and judicial risks that may happen in the controls to be made to your company in the future.



LEGISLATION CONSULTANCY AND SUPPORT SERVICES

- You can check your job tracking, checking account status and stock digitally via e-gümrük (e-customs)
- When the job instructions or invoices are sent in excel format, we transfer them to declaration system by integrating them into the system, and this way we save from the time.
- We do not compromise on our quality with regard to license and equipment by providing necessary equipments and controls to our data processing in this regard. We certified our quality with ISO27001 certificate.
- We make the recognition of the Inward Process Authorization Certificate to our customs program and this way we can abolish the possible mistakes in the declaration. Also we prevent the mistakes that may occur because of your customer representative.
- Our data process information is daily backed up in storage area outside by Turkcell backup management and in the company by Local backup management. Besides they are kept in two different places by updating the monthly solid storage devices.


